Based upon the statistic that nearly 50% of those age 85+ will have Alzheimer's Disease or other form of dementia, a conservative estimated growth in Cayuga County would result in the following: an additional 207 persons 85+ afflicted with dementia by 2010 and an additional 238 persons 85+ afflicted with dementia by 2015.
