The following resolution was moved, seconded and passed:

**WHEREAS**, the Town of Sennett desires to resolve and settle certain proceedings filed by the petitioner, **BUCKEYE PIPE LINE COMPANY LP**, to review the assessments under Article 7 of the Real Property Tax Law with respect to the petitioners' property within the Town of Sennett and identified by tax map numbers 109.02-1-11, 109.02-1-12 and 109.02-1-13 for the tax years 2009/2010, 2010/2011 and 2011/2012.

**NOW, THEREFORE**, be it resolved as follows:

**Section 1.** That the Stipulation of Settlement concerning the above-referenced Article 7 proceedings in the form annexed hereto be and hereby is approved and authorized by the Town of Sennett.

**Section 2.** That the attorney for the Town of Sennett is hereby authorized to execute said Stipulation on behalf of the Town of Sennett and to thereafter upon execution by the petitioner present the same to the Court in support of its Order of Settlement resolving the above-referenced proceedings.

The question of adoption of the foregoing resolution and Order was duly put to a roll call which resulted as follows: Councilman Eades yes, Councilwoman Cool absent, Councilman Gage yes, Councilman O'Connell yes and Supervisor Herrick yes.

The resolution and Order were thereupon declared to be adopted.
