ADOPTED: March 6, 1996

LOCAL LAW # 1 - 1997  
REGULATING SNOW AND ICE REMOVAL ON THE. SIDEWALKS IN THE  
VILLAGE OF CATO AND PROVIDING FOR PENALTIES FOR VIOLATION  
THEREOF  
ADOPTED: December 3, 1997

LOCAL LAW # 1-1999  
RELATING TO THE TERMINATION OF A VILLAGE'S STATUS AS AN  
ASSESSING UNIT FOR VILLAGE REAL PROPERTY TAX PURPOSES  
ADOPTED: February 3, 1999--Subject to permissive referendum no petition filed as of  
March 5, 1999 (30 days)

LOCAL LAW # 2-1999  
ADULT ENTERTAINMENT MORATORIUM FOR THE VILLAGE OF CATO  
ADOPTED: March 24, 1999

LOCAL LAW # 1-2000  
TO REGULATE ADULT ORIENTED BUSINESS IN THE VILLAGE OF CATO  
ADOPTED: February 9, 2000
